## 1. Awarding Entity:

The Foundation for the Development of the Education System seated in Warsaw, Al. Jerozolimskie 142 A, 02-305 Warsaw announces the Request for Tenders excluded from the obligation to apply the provisions of the Public Procurement Law for services consisting of accreditation and monitoring of organisations from the Eastern Partnership (EaP) countries (Armenia, Azerbaijan, Georgia, Belarus, Moldova, Ukraine) and the Russian Federation as well as from other partner countries named by the European Commission applying for Quality Label as part of the European Solidarity Corps and to monitor already accredited organisations.

- 2. Description of subject matter of contract constitutes Annex no. 1 to the Request for a proposal.
- 3. **Term of the Contract**: two years from the date of Contract signing.

## 4. Requirements from Economic Operators:

For the procurement may compete the Economic Operators who proves, he disposes of a person who:

- a) has command of English on the level allowing for unconstrained verbal and written communication minimal level B2.
- b) has practical computer skills (MS Office, IT tools for online submission of documents),
- c) Has experience in implementation of min. 3 volunteering projects in frames of European Voluntary Service (EVS), Erasmus+ and/or European Solidarity Corps as a project coordinator or a person supporting a project or/and experience in implementation of training activities on the topic of volunteering projects within above mentioned programmes,
- d) Has experience in implementation of min. 3 projects in the area of informal education of youth and persons working with youth in one of the EaP countries or in the Russian Federation, e.g. as project coordinator. educator, informal education trainer, pedagogue, instructor, tutor, expert, inspector, researcher etc.
- e) Has knowledge about aims and methods of implementation of European Solidarity Corps volunteering projects.

## 5. Tender evaluation criteria and their weight:

- 5.1 **Criterion I** (X1): experience in implementation of European Voluntary Service(EVS) or European Solidarity Corps projects as a project coordinator or a person supporting a project, or/and experience in implementation of training activities on the topic of volunteering projects within above mentioned programmes different than listed in pt. 4 d) of the request for proposal 20%
  - a) 10 points for implementation of 1 -3 additional volunteering projects
  - b) 20 points for implementation of 4 additional volunteering projects or more.
- 5.2 **Criterion II** (X2): Experience in conducting accreditations and/or Youth and/of monitoring in frames of Erasmus+ and/of Quality Label for National Agencies or Regional SALTO Resource Centres 35%
  - a) 25 point for conducting from 2 to 4 accreditations/ monitorings in frames of the above mentioned programmes
  - b) 35 points for conducting 5 or more accreditations/ monitorings in frames of the above mentioned programmes.
- 5.3 **Criterion III** (X3): experience in implementation of volunteering projects in frames of programmes different than European Voluntary Service(EVS) or European Solidarity Corps 15%. 15 points for implementation of min.2 projects in frames of these programmes.
- 5.4 **Criterion IV** (X4): experience in implementation of accreditations or assessment of applications for project grants in frames of educational and/or volunteering programmes different than European Voluntary Service(EVS) or European Solidarity Corps 15%.
  - a) 10 points for implementation of 3-5 accreditations or assessments of project grants,
  - b) 15 points for implementation of 6 or more accreditations or assessments of project grants.
- 5.5 Criterion V (X5): fluent command of one of the official languages of the Eastern Partnership region and Russia (Azeri, Belarusian, Georgian, Armenian, Russian, Romanian, Ukrainian) min. B2 15%. 15 points for knowledge of min. 1 official language of the above mentioned countries.

The most advantageous tender shall be deemed the tender of the Economic Operator which receives the highest score in specific evaluation criteria according to the formula: X1+X2+X3+X4+X5.

6. **Draft Contract/ Essential Terms of Contract** (guarantee, acceptance and payment conditions, forecasted amendments of the Contract and conditions thereof) shall constitute **Annex no. 3** to the Request for a proposal.

The Awarding Entity informs that will sign contracts with 22 Contractors, whose offers receive the highest number of points according to criteria of the assessment of proposals and will fulfill requirements specified in point 4 of the request for a proposal.
