

Request for Tenders no. dzp.262.96.2021

1. The Awarding Entity:

The Foundation for the Development of the Education System seated in Warsaw, al. Jerozolimskie 142a, 02-305 announces the Request for Tenders excluded from the obligation to apply the provisions of the Public Procurement Law **for the organisation of the following events: training for European Solidarity Corps (ESC) volunteers working in the Eastern European countries, the Caucasus region and the Russian Federation; meetings of coordinators of volunteering activities; annual meetings of former volunteers (Annual events); training for youth workers; contact seminars; meetings of persons responsible for youth policy; meetings of ESC trainers and persons responsible for accreditation; meetings of the SALTO network in Ukraine.**

2. Description of subject matter of contract constitutes **Annex no. 1** to the Request for Tenders.

3. Term of the Contract: from the date of Contract signing until 31 December 2022 or until the available funds are exhausted.

4. Requirements from Economic Operators:

Economic Operators who have experience in organising **at least 5** youth events concerning non-formal education in Ukraine over the past 12 months calculated from the date of tender submission, as listed in **Annex no. 4** to the Request for Tenders.

5. Tender evaluation criteria and their weight:

a) Price - 60%

In accordance with the model:

$$\text{number of points} = \frac{\text{the lowest price}}{\text{the tender price}} * 60$$

b) Experience – 40%

experience of the Economic Operator in organising youth events concerning non-formal education in Ukraine over the past 12 months calculated from the date of tender submission - 40%:

An Economic Operator will be awarded **5 points** for each **additional (other than listed to confirm the requirements from 4th point of request for tenders) organised youth event concerning non-formal education in Ukraine** listed in **Annex no. 4** to the Request for Tenders - experience - 40% (max. 40 points).

6. Draft Contract shall constitute **Annex no. 3** to the Request for Tenders.

10. Time limit for tender validity is 30 days.

16. The Contracting Entity informs that in accordance with applicable law the Request for tenders does not constitute an offer within the meaning of Article 66 of Polish act of 23 April 1964 Civil Code (OJ of 2020, item1740).
