





## Request for Tenders dzp.262.33.2023

## 1. The Awarding Entity:

The Foundation for the Development of the Education System seated in Warsaw, al. Jerozolimskie 142a, 02-305 announces the Request for Tenders excluded from the obligation to apply the provisions of the Public Procurement Law for the organisation of events in Georgia (region Samtskhe-Javakheti): trainings for European Solidarity Corps (ESC) volunteers working in the Eastern European countries and the Caucasus region; meetings of coordinators of volunteering activities; annual meetings of former volunteers (Annual events); training for youth workers; contact seminars; Erasmus+ events; meetings of persons responsible for youth policy; meetings of ESC trainers and persons responsible for accreditation; meetings of the SALTO network.

- 2. **Description of subject matter of contract** constitutes **Annex no. 1** to the Request for Tenders.
- 3. **Term of the Contract**: from the date of Contract signing until 31 December 2023 or until the funds provided for in the contract are exhausted.

## 4. Requirements from Economic Operators:

Economic Operators who have experience in organising at least 5 youth events concerning non-formal education in Georgia over the past 12 months calculated from the date of tender submission, as listed in **Annex no. 4** to the Request for Tenders.

5. Tender evaluation criteria and their weight:

Criterion 1 (X1): **Price - 60%** Points scale: 0 - 60

number of points  $X_1 = \frac{\text{the lowest price}}{\text{the tender price}} * 60$ 

Criterion 2 (X2): experience of the Economic Operator in organising youth events concerning non-formal education in Georgia over the past 12 months calculated from the date of tender submission - 40%:

An Economic Operator will be awarded **5 points** for each **additional** organised **youth event concerning non-formal education in Georgia** listed in **Annex no. 4** to the Request for Tender - experience - 40% (max. 40 points).

- 6. **Draft Contract/ Essential Terms of Contract** (guarantee, acceptance and payment conditions, forecasted amendments of the Contract and conditions thereof) shall constitute **Annex no. 3** to the Request for Tenders.

- 15. Proposals submitted after the deadline and variants will be rejected.
- 16. The Contracting Entity informs that in accordance with applicable law the Request for Proposals does not constitute an offer within the meaning of Article 66 of Polish act of 23 April 1964 Civil Code (OJ of 2020, item 1740).
