Criterion III (X3): fluent command of one of the official languages of the Eastern Partnership region and Russia (Azeri, Belarusian, Georgian, Armenian, Russian, Romanian, Ukrainian) 20%. 20 points for knowledge of min. 1 official language of the above mentioned countries.
