

**Request for Tenders no. dzp.262.93.2021**

**1. The Awarding Entity:**

The Foundation for the Development of the Education System seated in Warsaw, al. Jerozolimskie 142a, 02-305 announces the Request for Tenders excluded from the obligation to apply the provisions of the Public Procurement Law **for the organisation of the following events: training for European Solidarity Corps (ESC) volunteers working in the Eastern European countries, the Caucasus region and the Russian Federation; meetings of coordinators of volunteering activities; annual meetings of former volunteers (Annual events); training for youth workers; contact seminars; meetings of persons responsible for youth policy; meetings of ESC trainers and persons responsible for accreditation; meetings of the SALTO network in Georgia.**

**2. Description of subject matter of contract** constitutes **Annex no. 1** to the Request for Tenders.

**3. Term of the Contract:** from the date of Contract signing until 31 December 2022 or until the available funds are exhausted.

**4. Requirements from Economic Operators:**

Economic Operators who have experience in organising **at least 5** youth events concerning non-formal education in Georgia over the past 12 months calculated from the date of tender submission, as listed in **Annex no. 4** to the Request for Tenders.

**5. Tender evaluation criteria and their weight:**

**a) Price - 60%**

*In accordance with the model:*

$$\text{number of points} = \frac{\text{the lowest price}}{\text{the tender price}} * 60$$

**b) Experience – 40%**

**experience of the Economic Operator in organising youth events concerning non-formal education in Georgia over the past 12 months calculated from the date of tender submission - 40%:**

An Economic Operator will be awarded **5 points** for each **additional (other than listed to confirm the requirements from 4<sup>th</sup> point of request for tenders) organised youth event concerning non-formal education in Georgia** listed in **Annex no. 4** to the Request for Tenders - experience - 40% (max. 40 points).

**6. Draft Contract** shall constitute **Annex no. 3** to the Request for Tenders.
